Pool and Lagoon Monitors and/or Lifeguards supplement parental supervision; they do not take the place of parental supervision. Always keep a close eye on your children when they are in the water. When supervising children in the water, parents should not use cell phones, read books or engage in activities poolside that take attention from supervising children. Children, even those that have learned to swim, can become distressed or submerged in seconds. Please help keep SAMLARC Pools, Waders and Swim Lagoon safe for your child by paying close attention to them at all times.
